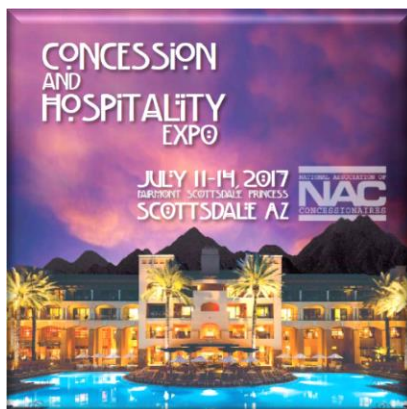

**Equipment Manufacturer**

An individual or company representative engaged in the manufacture and/or sale of any and all foods, beverages, or supplies for use in the leisure-time foodservice industry.

**Popcorn Processor**  
An individual or company representative engaged in the growing or processing of popcorn for sale to the wholesale or retail channels of distribution.

**Jobber/Distributor**  
An individual or company representative engaged in the manufacture and/or purchase, warehouse and resale of food items, equipment and supplies for the leisure-time foodservice industry.

**Manufacturer/Wholesaler**  
An individual or company representative engaged in the popping or packaging of popcorn for distribution through retail outlets.

**Broker**  
An individual or company representative engaged in the brokered sale of recreation and leisure-time foodservice equipment, products or supplies.

**Consultant/Architect**
